

## **NATURAL KANSAS WEBSITE APPLICATION**

The website <http://www.naturalkansas.org> is designed to attract tourists to visit and enjoy the premier natural places in Kansas. It is sponsored by the Kansas Chickadee Checkoff Program and administered by the Kansas Nature-Based Tourism Alliance (KNBTA). Selection of sites to be added to the Natural Kansas website is based upon uniqueness of the area and/or diversity of natural attractions. All sites must meet the following KNBTA Website Standards:

- Placement of organizations, events and businesses within the Natural Kansas website shall be based on that group, event, or business adhering to the Mission of the Kansas Nature-Based Tourism Alliance (KNBTA). "The Mission of the Kansas Nature-Based Tourism Alliance is to conserve, enhance and promote natural resources and experiences in Kansas."
- A primary emphasis of the organization, event or business wishing to be listed on the website should be non-consumptive, nature-based activities operated according to sound land, water and wildlife conservation principles.
- When the above is not evident, a written statement will need to be submitted to the website committee describing how the organization, event or business meets the required criteria.

The Website Selection Committee consists of: the Webmaster; KNBTA Coordinator; Kansas Department of Wildlife and Parks Wildlife Diversity Coordinator and a Kansas Department of Commerce and Housing representative.

Please complete the Natural Area Information Form and mail, fax, or e-mail to the KNBTA Coordinator. Promising sites will be visited and assessed by KNBTA representatives.
